

THE EQUIVALENCE OF MANN ITERATION AND ISHIKAWA ITERATION FOR NON-LIPSCHITZIAN OPERATORS

We show that the convergence of Mann iteration is equivalent to the convergence of Ishikawa iteration for various classes of non-Lipschitzian operators.

1. Introduction. Let X be a real Banach space, B a nonempty, convex subset of X , and $T : B \rightarrow B$ an operator. Let $u_1, x_1 \in B$. The following iteration is known as Mann iteration (see [6]):

$$u_{n+1} = (1 - \alpha_n)u_n + \alpha_n T u_n. \quad (1.1)$$

The sequence $(\alpha_n)_n \subset (0, 1)$ is convergent such that

$$\lim_{n \rightarrow \infty} \alpha_n = 0, \quad \sum_{n=1}^{\infty} \alpha_n = \infty. \quad (1.2)$$

Ishikawa iteration is given by (see [5])

$$\begin{aligned} x_{n+1} &= (1 - \alpha_n)x_n + \alpha_n T y_n, \\ y_n &= (1 - \beta_n)x_n + \beta_n T x_n, \quad n = 1, 2, \dots \end{aligned} \quad (1.3)$$

The sequences $(\alpha_n)_n, (\beta_n)_n \subset (0, 1)$ are convergent such that

$$\lim_{n \rightarrow \infty} \alpha_n = 0, \quad \lim_{n \rightarrow \infty} \beta_n = 0, \quad \sum_{n=1}^{\infty} \alpha_n = \infty. \quad (1.4)$$

Moreover, the sequence $(\alpha_n)_n$ from (1.3) is the same as in (1.1).

The map $J : X \rightarrow 2^{X^*}$ given by $Jx := \{f \in X^* : \langle x, f \rangle = \|x\|^2, \|f\| = \|x\|\}$, for all $x \in X$, is called the *normalized duality mapping*. The Hahn-Banach theorem assures that $Jx \neq \emptyset$, for all $x \in X$. It is easy to see that we have $\langle j(x), y \rangle \leq \|x\| \|y\|$, for all $x, y \in X$ and for all $j(x) \in J(x)$.

DEFINITION 1.1. Let X be a real Banach space and let B be a nonempty subset. A map $T : B \rightarrow B$ is called strongly pseudocontractive if there exist $k \in (0, 1)$ and a $j(x - y) \in J(x - y)$ such that

$$\langle Tx - Ty, j(x - y) \rangle \leq k \|x - y\|^2, \quad \forall x, y \in B. \quad (1.5)$$

A map $S : D(S) \rightarrow X$ is called strongly accretive if there exist $k \in (0, 1)$ and a $j(x - y) \in J(x - y)$ such that

$$\langle Sx - Sy, j(x - y) \rangle \geq k\|x - y\|^2, \quad \forall x, y \in D(S). \quad (1.6)$$

In (1.5), when $k = 1$, T is called *pseudocontractive*. In (1.6), when $k = 0$, S is called *accretive*. We denote by I the identity map.

REMARK 1.2. (i) The operator T is (strongly) pseudocontractive map if and only if $(I - T)$ is (strongly) accretive.

(ii) If S is accretive map, then $T = f - S$ is strongly pseudocontractive map.

Remark 1.2(i) is obvious from (1.5) and (1.6). For Remark 1.2(ii), supposing that $x, y \in B$ and $j(x - y) \in J(x - y)$, one obtains

$$\begin{aligned} \langle Sx - Sy, j(x - y) \rangle \geq 0 &\iff \langle (f - T)x - (f - T)y, j(x - y) \rangle \geq 0 \\ &\iff \langle Tx - Ty, j(x - y) \rangle \leq 0 \leq k\|x - y\|^2, \end{aligned} \quad (1.7)$$

for all $k \in (0, 1)$.

In [10], it was shown that the Mann and Ishikawa iterations are equivalent for various classes of Lipschitzian operators. We prove here the equivalence for non-Lipschitzian operators. For this purpose, we need several lemmas.

LEMMA 1.3 [11]. *Let $(a_n)_n$ be a nonnegative sequence which satisfies the following inequality:*

$$a_{n+1} \leq (1 - \lambda_n)a_n + \sigma_n, \quad (1.8)$$

where $\lambda_n \in (0, 1)$, for all $n \in \mathbb{N}$, $\sum_{n=1}^{\infty} \lambda_n = \infty$, and $\sigma_n = o(\lambda_n)$. Then $\lim_{n \rightarrow \infty} a_n = 0$.

It is known that $J(x) = \partial\phi(x)$, where $\phi(x) = (1/2)\|x\|^2$ and $\partial\phi(x)$ denotes the subdifferential of $\phi(x)$ at x , so the following inequality is satisfied, see also [1, Lemma 2.1] or [9, Lemma 1].

LEMMA 1.4 [1, 9]. *If X is a real Banach space, then the following relation is true:*

$$\|x + y\|^2 \leq \|x\|^2 + 2\langle y, j(x + y) \rangle, \quad \forall x, y \in X, \quad \forall j(x + y) \in J(x + y). \quad (1.9)$$

2. Main result. We are now able to prove the following result.

THEOREM 2.1. *Let X be a real Banach space with a uniformly convex dual and B a nonempty, closed, convex, and bounded subset of X . Let $T : B \rightarrow B$ be a continuous and strongly pseudocontractive operator. Then for $u_1 = x_1 \in B$, the following assertions are equivalent:*

- (a) Mann iteration (1.1) converges to the fixed point of T ;
- (b) Ishikawa iteration (1.3) converges to the fixed point of T .

PROOF. Deimling [3, Corollary 1] assures the existence of a fixed point. The uniqueness of the fixed point comes from (1.5). Because X^* is uniformly convex, the duality map is single valued (see, e.g., [4]). Using (1.1), (1.3), and Lemma 1.4, we get

$$\begin{aligned}
 \|x_{n+1} - u_{n+1}\|^2 &= \|(1 - \alpha_n)(x_n - u_n) + \alpha_n(Ty_n - Tu_n)\|^2 \\
 &\leq (1 - \alpha_n)^2 \|x_n - u_n\|^2 + 2\alpha_n \langle Ty_n - Tu_n, J(x_{n+1} - u_{n+1}) \rangle \\
 &= (1 - \alpha_n)^2 \|x_n - u_n\|^2 \\
 &\quad + 2\alpha_n \langle Ty_n - Tu_n, J(x_{n+1} - u_{n+1}) - J(y_n - u_n) \rangle \\
 &\quad + 2\alpha_n \langle Ty_n - Tu_n, J(y_n - u_n) \rangle \\
 &\leq (1 - \alpha_n)^2 \|x_n - u_n\|^2 + 2\alpha_n k \|y_n - u_n\|^2 \\
 &\quad + 2\alpha_n \langle Ty_n - Tu_n, J(x_{n+1} - u_{n+1}) - J(y_n - u_n) \rangle \\
 &\leq (1 - \alpha_n)^2 \|x_n - u_n\|^2 + 2\alpha_n k \|y_n - u_n\|^2 \\
 &\quad + 2\alpha_n \|Ty_n - Tu_n\| \|J(x_{n+1} - u_{n+1}) - J(y_n - u_n)\| \\
 &\leq (1 - \alpha_n)^2 \|x_n - u_n\|^2 + 2\alpha_n k \|y_n - u_n\|^2 \\
 &\quad + 2\alpha_n M_1 \|J(x_{n+1} - u_{n+1}) - J(y_n - u_n)\|,
 \end{aligned}
 \tag{2.1}$$

for some positive constant M_1 . Observe that $(\|Ty_n - Tu_n\|)_n$ is bounded. We now prove that

$$J(x_{n+1} - u_{n+1}) - J(y_n - u_n) \rightarrow 0 \quad (n \rightarrow \infty).
 \tag{2.2}$$

Deimling [4, Proposition 12.3, page 115] assures that when X^* is uniformly convex, J is uniformly continuous on every bounded set of X . To prove (2.2), it is sufficient to see that

$$\begin{aligned}
 &\|(x_{n+1} - u_{n+1}) - (y_n - u_n)\| \\
 &= \|(x_{n+1} - y_n) - (u_{n+1} - u_n)\| \\
 &= \|-\alpha_n x_n + \alpha_n Ty_n + \beta_n x_n - \beta_n Tx_n + \alpha_n u_n - \alpha_n Tu_n\| \\
 &\leq \alpha_n (\|x_n\| + \|Ty_n\| + \|u_n\| + \|Tu_n\|) + \beta_n (\|x_n\| + \|Tx_n\|) \\
 &\leq (\alpha_n + \beta_n)M \rightarrow 0 \quad (n \rightarrow \infty),
 \end{aligned}
 \tag{2.3}$$

where

$$M = \sup_n ((\|x_n\| + \|Ty_n\| + \|u_n\| + \|Tu_n\|), (\|x_n\| + \|Tx_n\|)) < \infty.
 \tag{2.4}$$

The sequences $(u_n)_n$, $(x_n)_n$, $(Tx_n)_n$, $(Tu_n)_n$, and $(Ty_n)_n$ are bounded being in the bounded set B . Hence one can see that the M above is finite and (2.2) holds. We define

$$\sigma_n := 2\alpha_n M_1 \|J(x_{n+1} - u_{n+1}) - J(y_n - u_n)\|.
 \tag{2.5}$$

Again, using (1.1) and (1.3), we get

$$\begin{aligned} \|\mathcal{Y}_n - u_n\|^2 &= \|(1 - \beta_n)(x_n - u_n) + \beta_n(Tx_n - u_n)\|^2 \\ &\leq (1 - \beta_n)^2\|x_n - u_n\|^2 + 2\beta_n\langle Tx_n - u_n, J(\mathcal{Y}_n - u_n) \rangle \\ &\leq \|x_n - u_n\|^2 + \beta_n M_2. \end{aligned} \tag{2.6}$$

The last inequality is true because $(\langle Tx_n - u_n, J(\mathcal{Y}_n - u_n) \rangle)_n$ is bounded, with a constant $M_2 > 0$. Replacing (2.5) and (2.6) in (2.1), we obtain

$$\begin{aligned} \|\mathcal{X}_{n+1} - u_{n+1}\|^2 &\leq (1 - \alpha_n)^2\|x_n - u_n\|^2 + 2\alpha_n k\|x_n - u_n\|^2 \\ &\quad + \sigma_n + \alpha_n(2k)\beta_n M_2 \\ &= (1 - 2(1 - k)\alpha_n + \alpha_n^2)\|x_n - u_n\|^2 + o(\alpha_n). \end{aligned} \tag{2.7}$$

The condition $\lim_{n \rightarrow \infty} \alpha_n = 0$ implies the existence of an n_0 such that, for all $n \geq n_0$, we have

$$\alpha_n \leq (1 - k). \tag{2.8}$$

Substituting (2.8) into (2.7), we get

$$1 - 2(1 - k)\alpha_n + \alpha_n^2 \leq 1 - 2(1 - k)\alpha_n + (1 - k)\alpha_n = 1 - (1 - k)\alpha_n. \tag{2.9}$$

Finally,

$$\|\mathcal{X}_{n+1} - u_{n+1}\|^2 \leq (1 - (1 - k)\alpha_n)\|x_n - u_n\|^2 + o(\alpha_n). \tag{2.10}$$

With $a_n := \|x_n - u_n\|^2$, $\lambda_n := (1 - k)\alpha_n \in (0, 1)$, and using Lemma 1.3, we obtain $\lim_{n \rightarrow \infty} a_n = \lim_{n \rightarrow \infty} \|x_n - u_n\|^2 = 0$, that is,

$$\lim_{n \rightarrow \infty} \|x_n - u_n\| = 0. \tag{2.11}$$

Let x^* be the fixed point of T . Suppose that $\lim_{n \rightarrow \infty} u_n = x^*$. The inequality

$$0 \leq \|x^* - x_n\| \leq \|u_n - x^*\| + \|x_n - u_n\| \tag{2.12}$$

and (2.11) imply that $\lim_{n \rightarrow \infty} x_n = x^*$. Analogously, $\lim_{n \rightarrow \infty} x_n = x^*$ implies $\lim_{n \rightarrow \infty} u_n = x^*$. □

REMARK 2.2. (i) If T has a fixed point, then Theorem 2.1 holds without the continuity of T .

(ii) If B is not bounded, then Theorem 2.1 holds, supposing that $(x_n)_n$ is bounded. The point was to prove that if Mann iteration is convergent (thus bounded), then Ishikawa iteration is convergent too. We remark that having the convergence of Ishikawa iteration, one can immediately deduce the convergence of Mann iteration by setting $\beta_n = 0$ for all $n \in \mathbb{N}$ in (1.3).

Theorem 2.1 does not completely generalize the Lipschitzian case from [10] because the operator there is not necessarily bounded.

THEOREM 2.3 [10]. *Let K be a closed convex (not necessary bounded) subset of an arbitrary Banach space X and let T be a Lipschitzian pseudocontractive selfmap of K . We consider Mann iteration and Ishikawa iteration with the same initial point and with the conditions $\lim_{n \rightarrow \infty} \alpha_n = 0$, $\lim_{n \rightarrow \infty} \beta_n = 0$, and $\sum_{n=1}^{\infty} \alpha_n = \infty$. Let $x^* \in F(T)$. Then the following conditions are equivalent:*

- (i) Mann iteration (1.1) converges to $x^* \in F(T)$;
- (ii) Ishikawa iteration (1.3) converges to $x^* \in F(T)$.

3. Further equivalences. Let S be a strongly accretive operator. We consider when the equation $Sx = f$ has a solution for a given $f \in X$. It easy to see that

$$Tx = x + f - Sx, \quad \forall x \in X, \tag{3.1}$$

is a strongly pseudocontractive operator. A fixed point for T is the solution of $Sx = f$, and conversely. **Theorem 2.1** assures that the convergence of Mann and Ishikawa iterations to the fixed point of T are equivalent for bounded strongly pseudocontractive maps. A similar result holds for the convergence of Mann and Ishikawa iterations to the solution of $Sx = f$. Suppose that the operator S is strongly accretive. It is well known that if S is bounded, $(I - S)$ could be unbounded. Take, for example, $S : R \rightarrow B = [-1, 1]$ with $S(x) = (1/2) \cos x$. According to [2], the map $(I - S)(x) = x - (1/2) \cos x$ is strongly accretive and $(I - S)(R) = R$. Thus, if B is bounded and $x \in B$ does not mean that $Tx = x - Sx + f \in B$. For the same $(\alpha_n)_n, (\beta_n)_n \subset (0, 1)$ as in (1.4), iterations (1.1) and (1.3) become

$$x_{n+1} = (1 - \alpha_n)x_n + \alpha_n(f + (I - S)y_n), \tag{3.2}$$

$$y_n = (1 - \beta_n)x_n + \beta_n(f + (I - S)x_n), \quad n = 1, 2, \dots,$$

$$u_{n+1} = (1 - \alpha_n)u_n + \alpha_n(f + (I - S)u_n), \quad n = 1, 2, \dots \tag{3.3}$$

The existence of the solution for $Sx = f$ when S is a continuous and strongly accretive operator results from [8]. This argument and **Remark 2.2(ii)** lead us to the following corollary.

COROLLARY 3.1. *Let X be a real Banach space with a uniformly convex dual and B a nonempty, convex, and closed subset of X . Let $S : B \rightarrow B$ be a continuous and strongly accretive operator and let $(x_n)_n$, given by (3.2), be bounded. Then, for $u_1 = x_1 \in B$, the following assertions are equivalent:*

- (a) Mann iteration (3.3) converges to the solution of $Sx = f$;
- (b) Ishikawa iteration (3.2) converges to the solution of $Sx = f$.

Let S be an accretive operator. From [Remark 1.2\(ii\)](#), the operator $Tx = f - Sx$ is strongly pseudocontractive for a given $f \in X$. A solution for $Tx = x$ becomes a solution for $x + Sx = f$. For $(\alpha_n)_n, (\beta_n)_n \subset (0, 1)$, as in [\(1.4\)](#), iterations [\(1.1\)](#) and [\(1.3\)](#) become

$$x_{n+1} = (1 - \alpha_n)x_n + \alpha_n(f - Sy_n), \quad (3.4)$$

$$y_n = (1 - \beta_n)x_n + \beta_n(f - Sx_n), \quad n = 1, 2, \dots,$$

$$u_{n+1} = (1 - \alpha_n)u_n + \alpha_n(f - Su_n), \quad n = 1, 2, \dots \quad (3.5)$$

The existence of a solution for this equation follows from [\[7\]](#). We are now able to give the following result.

COROLLARY 3.2. *Let X be a real Banach space with a uniformly convex dual and B a nonempty, convex, and closed subset of X . Let $S : B \rightarrow B$ be a continuous and accretive operator and let $(x_n)_n$, given by [\(3.4\)](#), be bounded. Then, for $u_1 = x_1 \in B$, the following assertions are equivalent:*

- (a) Mann iteration [\(3.5\)](#) converges to the solution of $x + Sx = f$;
- (b) Ishikawa iteration [\(3.4\)](#) converges to the solution of $x + Sx = f$.

Observe that if S is not continuous, and the equations $Sx = f$, respectively, $x + Sx = f$, have solutions, then [Corollary 3.1](#), respectively, [Corollary 3.2](#) hold.

We remark that all the results from this paper hold in the multivalued case, provided that these multivalued maps admit appropriate single-valued selections.
